





### Who is a "Homeless" Veteran?

**Homeless** – a person who lacks a fixed, regular, and adequate nighttime residence. This includes people whose primary locations are:

- Sheltered: Designated emergency shelters, transitional housing programs, or safe havens.
- Unsheltered: Public or private places that are not ordinarily designated, or used, as shelter (e.g., streets, vehicles, or parks).

**Chronic Homelessness and Chronically Homeless People in Families** – either a person or people in families in which the head of household has a disability and who:

- Has been continuously homeless for at least one year.
- Has experienced at least four occasions of homelessness in the last three years where the combined length of time in those occasions is at least 12 months.

**Veteran** – An adult who served on active duty in the armed forces of the United States, including persons who served on active duty from the military reserves or the National Guard.

### **Coordinated Entry**

#### What is Coordinated Entry?

The coordinated entry process is an approach to coordination and management of a crisis response system's resources that allows users to make consistent decisions from available information to efficiently and effectively connect people to housing and service interventions that will rapidly end their homelessness. Through coordinated entry, a Continuum of Care (CoC) ensures that the highest need, most vulnerable households in the community are prioritized for housing and services first. *Its goal is to also ensure that a veterans homelessness is rare, brief and non-reoccurring.* 

#### Coordinated Entry Core Elements:

- 1. Access the initial engagement point (virtual or site-based, including multiple access sites) for persons experiencing a housing crisis.
- 2. Assessment process of documenting a participant's housing needs, preferences, and vulnerability.
- 3. Prioritization process of assigning level of need or vulnerability to persons seeking assistance so that housing and services can be allocated to those persons with the greatest need.
- 4. Referral matching persons to available community resources, housing and services.

### **Coordinated Entry**

#### Benefits of Coordinated Entry

- Veterans at risk of or experiencing homelessness are able to access housing or services they need faster.
- Veterans at risk of or experiencing homelessness are only referred to services for which they are eligible.
- Focus remains on most vulnerable or highest need Veteran households as opposed to leaving that population in homelessness
- Those Veterans who are most in need or vulnerable are prioritized for housing and service options first.

### Health Care for Homeless Veterans (HCHV)

- Outreach is a core mission of HCHV.
- The goal is to engage Veterans who are *not* receiving care through VA and enroll them in services. This is the "Health Care" in HCHV!
- Targeted outreach and community events such as Stand Downs and Point-in-Time (PIT) counts.
- Respond to calls from the National Homeless Call Center.
- Vocational Development Services.





### **Community Resource and Referral Center (CRRC)**

- The CRRC is designed to be a one-stop place for Veterans to access an array of VA services as well as community services in one central location. CRRCs can provide a wide range of services ranging from basic needs to clinical care.
- The CRRC at NF/SGVHS was funded in late FY 13 to expand services in Jacksonville.
- Our CRRC is unique in that we are partnering with our existing Service Center at the Clara White Mission to leverage resources rather than duplicate.
  - CWM will continue to offer the basic services such as showers, laundry, mail, phones etc. under the current funding stream from GPD.
  - CRRC will provide outreach/in-reach, groups, physical exams, dietary counseling, employment assistance and peer support.

### **HCHV Contract Treatment and Emergency Housing**

#### Meridian Behavioral Health Care

- 8 Beds in Gainesville
- Provides residential treatment in a supervised environment at their Sid Martin Bridge House
- LOS up to 180 days
- IM Sulzbacher Center and Sulzbacher Village (Women)
  - 14 Beds in Jacksonville
  - Provides emergency housing and case management services in a separate Veterans Dorm
  - LOS up to 90 days
- GRACE Market Place
  - 26 Beds in Gainesville
  - Provides emergency housing and case management
  - LOS up to 60 days



### Grant and Per-Diem (GPD) Transitional Housing

Effective 10/1/17, GPD has transformed and now operates under specific models, with specific eligibility requirements.

- <u>Clinical Treatment</u>: Homeless Veterans with a mental health and/or substance use disorder diagnosis who choose to engage in clinical services. This model provides clinically focused treatment in conjunction with services to assist Veterans in securing housing and increasing income. Length of stay is up to 6 months.
- <u>Bridge Housing</u>: Homeless Veterans that have been offered and accepted into a permanent housing intervention (e.g. SSVF or HUD-VASH) and are not able to immediately enter permanent housing. Length of stay is up to 90 days.
- <u>Service-Intensive</u>: Homeless Veterans who choose transitional housing environment providing services prior to entering permanent housing. Length of stay is up to 6 months.

# The Residence at the HONOR Center, Domiciliary Care for Homeless Veterans (DCHV)

- The HONOR Center Serves as the HUB for all specialized homeless services throughout NF/SGVHS.
- 45 Bed Specialized Mental Health Residential Rehabilitation Treatment Program (MHRRTP).
- Specializes in serving homeless Veterans by providing residential, psychosocial rehabilitation and treatment.
- Focus on caring for Veterans that are frail, elderly, have on going health care needs, or otherwise need more care than can be provided in one of our other programs.
- Self contained Domiciliary: services are provided in house.
- Operates 24/7.

### Housing and Urban Development-VA Supportive Housing (HUD-VASH)

- Partnership between VA and HUD.
  - HUD funds Housing Choice Vouchers (HCVs) to local Public Housing Authorities (PHAs) to provide rent subsidies based on income.
  - VA provides clinical support directly via VHA staff in the program as well as primary care, mental health care, and specialty care for health care eligible Veterans.
- NF/SG currently manages 1,720 total HUD-VASH vouchers throughout the system.
- Operates from a Housing First and Harm Reduction Public Health model.







# **HUD-VASH Eligibility Criteria**



- Eligible for VA Health Care.
- Homeless per HEARTH Act.
- Identified need for and agreement to participate in intensive case management.

## **HUD-VASH Priority Focus**

- Chronically Homeless
- High Acuity / Medically
   Vulnerable
- Must have a need for intensive case management



### A Note about "Eligibility"

• HUD-VASH is a clinical intervention, *not* a housing entitlement.

• Eligibility Criteria is intentionally broad as to not create barriers for high needs / high priority veterans.

• Although many Veterans are eligible for HUD-VASH not every eligible veteran is a priority.

### Supportive Services for Veteran Families (SSVF)

Under the SSVF Program, VA will award grants to private non-profit organizations and consumer cooperatives who will provide supportive services to very low-income Veteran families residing in or transitioning to permanent housing. The grantees will provide a range of supportive services designed to promote housing stability to eligible very low-income Veteran families.

When funding permits, most SSVF agencies provide the following services:

- Case management
- Temporary financial assistance for rent
- Financial assistance for deposits, utilities, and moving costs
- Emergency housing assistance
- Child care subsidies
- Employment assistance
- Transportation financial assistance (bus passes, car repairs)

### **HCHV Community Employment**

- Assists Veterans in establishing employment goals and strategies and ensures that Veterans seeking employment are aware of local, state, and federal services.
- Creates relationships and collaborates with local, state and federal agencies and organizations to identify and utilize resources that enable skilled Veterans to obtain and maintain competitive employment.
- Identifies and addresses barriers to employment for Veterans with disabilities who are ready to work, address barriers to job readiness training, recommends solutions for areas in need of improvement.



### Vocational Rehabilitation (VR)/Compensated Work Therapy (CWT)

Compensated Work Therapy (CWT) is a VA clinical vocational rehabilitation program. CWT programs strive to maintain highly responsive long term quality relationships with business, government agencies, and industry promoting employment opportunities for Veterans with physical and mental health challenges. VR/CWT staff provide:

- Evidence based and evidence informed vocational rehabilitation services.
- Partnerships with business, industry and government agencies to provide Veteran candidates for employment and Veteran labor.
- Employment supports to Veterans and employers.



### Mental Health Intensive Case Management (MHICM)

#### WHAT IS MHICM?

It is an outpatient program that:

- Provides community-based, intensive treatment for Veterans with severe and ongoing mental illness
- Meets with Veterans in the community and in their homes
- Helps Veterans meet recovery treatment goals set by the Veteran and the MHICM team

#### **Program Objectives:**

- Improve client ability to function in the community
- Improve development and use of personal skills and strengths
- Improve access to community resources
- Minimize the need for hospitalization

### WHAT ARE THE CRITERIA FOR THE MHICM PROGRAM?

Criteria includes, but is not limited to:

- ✓ 30 or more acute, consecutive VA mental health inpatient hospital days <u>or</u> 3 or more acute mental health hospital admissions during the past 12 calendar months
- ✓ Medically stable
- Primary diagnosis of chronic and severe schizophrenia, schizoaffective disorder, bipolar disorder, major depression or post-traumatic stress disorder
- ✓ Agreement to take part in the program
- ✓ Living within a 50-mile radius and less than 60 minutes of the program location

### **Psychosocial Rehabilitation & Recovery**

#### Psychosocial Rehabilitation and Recovery Center (PRRC) What the Name Means: PRRC

**Psychosocial**– Psychological (mental/emotional) Health within a social environment.

**Rehabilitation**– The development of skills and supports to achieve goals; despite mental and/or physical challenges.

**Recovery**– Regaining purpose, a positive sense of self, the role of full citizen and community member, the capacity to cope with and overcome adversity, awareness of the gifts and lessons learned through healing.

**Center**– A place to address each individual's needs, honor strengths and cultural values, and actively encourage and support involvement in the community

### **Psychosocial Rehabilitation & Recovery**



#### About the Program

The NF/SG PRRC supports Veterans who have mental illnesses (such as Schizophrenia, Major Depression, Bipolar Disorder and Severe PTSD) in developing skills, support systems, and wellness strategies to help improve their quality of life. Veterans participate in classes aimed at helping them become more involved in their community by managing their symptoms, improving communication and coping skills.

The program helps Veterans with mental illness lead more fulfilling lives and develops their full potential. The foundation of the program is a strong belief that all people, regardless of the presence of physical or mental symptoms, have the power to learn and grow, the right to dignity and respect for all citizens, and the opportunity to enjoy and benefit from meaningful work and play as productive community members.

#### Overview

Community Resource and Referral Centers (CRRC) are places where Veterans who are hom eless or at risk of hom elessness can get connected to stable housing and supportive services. Through the National Center on Homelessness Among Veterans, this "one-stop shopping" hom eless service model is being tested in densely populated areas, strategically located sites across the country. CRRCs are collaborative, multi-agency, multidisciplinary programs that provide access to housing, health care, job development programs, and other VA and non-VA benefits.

#### Goals & Objectives

The primary goal of the CRRC is to provide rapid and comprehensive housing related services to Veterans who are experiencing homelessness, especially the chronically homeless, and to assist at-risk Veterans in maintaining their current housing. CRRCs are committed to increasing access to homeless services by creating a welcoming environment for integrated service delivery.
