FY2025 HUD NOFO

LOCAL CoC Priorities

1. Renewal Coordinated Entry System (CES) and Homeless Management Information (HMIS) System Projects
2. New Transitional Housing (TH) Projects | \$200,000 - \$2 Million
3. New Supportive Services Only | Up to \$500,000 - serve all CoC counties
4. New Supportive Services and Outreach | Up to \$500,000 - serve all CoC counties
5. New Permanent Housing (PH – PSH and RRH) Projects | \$500,000 - \$2.5 million
6. Renewal Permanent Housing Projects
